 - 3. If the voting rights are exercised electronically, there is no need to use this Postal Ballot Form.

INSTRUCTIONS

- 1. This Postal Ballot Form is provided for the benefit of Members who do not have access to e-voting facility.
- 2. A Member can opt for only one mode of voting, i.e. either through e-voting or by Postal Ballot Form. If a Member casts his/ her vote using both modes, then voting done through e-voting shall prevail and Postal Ballot Form shall be treated as invalid. The voting period will commence on and from Thursday, 28th February, 2019 at 9:00 a.m. (IST) and ends on Friday, 29th March, 2019 at 5:00 p.m. (IST).
- 3. A Member desiring to exercise vote by Postal Ballot may complete this Postal Ballot Form and send it to the Scrutinizer at Karvy Fintech Private Limited, Karvy Selenium Tower B, Plot No. 31-32, Gachibowli, Financial District, Nanakramguda, Hyderabad 500032 in the enclosed postage pre-paid self-addressed Business Reply Envelope.
- 4. Envelopes containing postal ballot form, if sent by courier at the expense of the Member will also be accepted.
- 5. This Form should be completed and signed by the Member (as per the specimen signature registered with the Company/ Depository Participants). In case of joint holding, this form should be completed and signed by the first named Member and in his/her absence, by the next named Member.
- 6. In case of shares held by companies, trusts, societies etc., the duly completed postal ballot form should be accompanied by a certified true copy of Board Resolution/Authorisation together with the specimen signature(s) of the duly authorised signatory(ies). A Member may sign the Form through an Attorney, in which case a copy of the Power of Attorney should be attached to the Postal Ballot Form. Where the form has been signed by a representative of the President of India or of the Governor of a State, a certified copy of the nomination should accompany the postal ballot form.
- 7. The consent must be accorded by recording the assent in the Column 'FOR' and dissent in the column 'AGAINST' by placing a tick mark (✓) in the appropriate column.
- 8. An incomplete, unsigned, incorrectly completed, incorrectly ticked, defaced, torn, multilated, overwritten, wrongly signed Postal Ballot Form will be rejected. Members are requested to fill the Postal Ballot Form in indelible ink and avoid filling it by using erasable writing medium(s) like pencil.
- 9. A Member need not use all his/her votes nor cast all his/her votes in the same way. The right of voting by Postal Ballot cannot be exercised by a Proxy.
- 10. Duly completed postal ballot forms should reach the Scrutinizer not later than the close of working hours on Friday, 29th March, 2019. All postal ballot forms received after this date will be treated as if reply from such Member has not been received.
- 11. A Member may request for a duplicate postal ballot form, if so required. However, the duly filled in duplicate postal ballot form should reach the Scrutinizer not later than the date specified at item No. 10 above.
- 12. A Member is requested not to send any other paper along with the postal ballot form in the enclosed postage prepaid self-addressed Business Reply Envelope.
- 13. Voting rights shall be reckoned on the paid-up value of the equity shares registered in the name of the Member(s) as on Friday, 15th February, 2019.
- 14. The Scrutinizer's decision on the validity of a postal ballot form will be final.
- 15. The results of the Postal Ballot will be declared in the manner as specified in the Notice.
