2.0 M/s Jaypee Balaji Cement Plant was granted Environmental Clearance for Cement Plant (Cement -5.0 MTPA, Clinker -3.6 MTPA) along with Captive Power Plant (50 MW) at village Budawada, Mandal Jaggayyapeta, Dist. Krishna, Andhra Pradesh vide letter F.No.J-11011/821/2008-IAII(I) dated 26th November 2009.

3.0 Further, the project was granted Environmental Clearance for expansion by adding and additional Captive Power Plant (25 MW) vide letter F.No.J-11011/821/2008-IAII(I) dated 13th April 2016.

4.0 M/s Jaiprakash Associates Ltd and M/s Jaiprakash Cement Corporation Ltd transferred all its business arrangement to M/s Ultra Tech Cement Ltd by virtue of scheme of arrangement by the order of the National Company Law Tribunal, Mumbai Bench vide dated 7th March 2017.

5.0 Now, M/s Ultra Tech Cement Ltd made an application vide letter no. UTCL/Balaji/ENV/EC/2017/01 dated 5th October 2017 for aforesaid transfer of Environmetal Clearance and its subsequent clearance for expansion for adding and additional Captive Power Plant (25 MW).
